

NOTICE PURSUANT TO ART. 13 OF EU REGULATION 2016/679

- NEWSLETTER -

ASSOCIAZIONE MUSICALE E CULTURALE ARS AETERNA, (Tax code and VAT no.: 03702890132) (hereinafter the "ASSOCIAZIONE"), in the person of its legal representative pro tempore, with registered office in Tramezzina (CO), via Stazione, 11, its capacity as Data Controller pursuant to Articles. 4 no. 7) and 24 of the EU Regulation no. 2016/679 (GDPR), informs you that, pursuant to art. 13 of the GDPR, your personal data, described in art. 1 below, will be processed for the processing purpose described in art. 2 below.

1. Category of personal data being processed

1.1. ASSOCIAZIONE collects and processes, for the purpose of pursuing the processing purpose described in Art. 2, your personal data pursuant to Art. 4 no. 1) of the GDPR, so-called identification data (e.g. e-mail address) requested within one or more specific forms present on the ASSOCIAZIONE's website (hereinafter "Site").

2. Purpose of the processing and legal basis.

2.1. Your personal data are processed by the ASSOCIAZIONE for the performance of the following purpose, subject to your specific, informed, free and unequivocal consent:

- a. Sending of commercial/promotional communications, to be carried out by automated/electronic/telematic means (e.g. e-mail).

In compliance with Article 13(2)(c) of the GDPR, ASSOCIAZIONE informs you of your right to withdraw, at any time, any consent you may have given for the purpose of processing described in Article 2.1. letter a), without this event, however, affecting the lawfulness of the processing based on the consent given before the withdrawal.

In this regard, ASSOCIAZIONE specifies that the legal basis of the processing purpose described in Art. 2.1. letter a) is to be found in the following regulatory provisions: Art. 6 paragraph 1) letter a) of the GDPR; Art. 130 paragraphs 1) and 2) of the new D. Legislative Decree no. 196/2003 (Privacy Code).

3. Retention period.

3.1. In compliance with Art. 13 paragraph 2) letter a) of the GDPR, ASSOCIAZIONE informs you of the following storage period/criteria, after which your personal data will be subject to deletion, destruction or anonymisation: **(i)** for the performance of the processing purpose referred to in Art. 2.1. letter a): until your consent is revoked.

4. Target audience.

4.1. In compliance with art. 13 paragraph 1) letter e) of the GDPR, ASSOCIAZIONE specifies that your personal data may be subject to communication, where appropriate and necessary, to one or more recipients pursuant to art. 4 no. 9) of the GDPR, identified, in general, by category as follows: **(i)** for the performance of the processing purpose referred to in art. 2.1. letter a): parties authorised to process data by the ASSOCIAZIONE; consultants or companies of various kinds that provide, in any case, services and/or services (including professional services) connected, even indirectly, to the performance of the purpose in question (e.g. marketing/ICT companies).

5. Transfer.

5.1. ASSOCIAZIONE hereby specifies that your personal data are/may be stored in automated, partially automated or non-automated files belonging to or in any event traceable, even indirectly, to the latter, and located within the European Economic Area (EEA).

6. Rights of the data subject.

6.1. In relation to your personal data, ASSOCIAZIONE informs you of your right to exercise the following rights, which may be subject to the limitations provided for in Articles 2-undecies and 2-duodecies of the Privacy Code: right of access pursuant to Article 15 of the GDPR: right to obtain confirmation as to whether or not personal data is being processed, in addition to the information referred to in Article. 15 of the GDPR (e.g. purpose of processing; categories of data concerned; storage period); right to rectification ex art. 16 of the GDPR: right to correct, update or supplement personal data; right to erasure ex art. 17 of the GDPR: right to obtain the deletion or destruction or anonymisation of personal data, where the conditions listed in the same article are met; right to restriction of processing under Art. 18 of the GDPR: right to obtain the restriction of processing where the conditions governed by Art. 18 exist. 18; the right to data portability under Article 20 of the GDPR: the right to obtain personal data, provided to the Data Controller, in a structured, commonly used and machine-readable format (and, where required, to transmit them directly to another Data Controller). Where the specific conditions indicated by the same article are met (e.g. legal basis of consent and/or performance of a contract; personal data provided by the data subject); right of objection under Art. 21 of the GDPR: right to obtain the cessation, on a permanent basis, of a certain processing of personal data; right to lodge a complaint with the Supervisory Authority (i.e. Italian Privacy Guarantor) under Art. 77 of the GDPR: right to lodge a complaint where it is considered that the processing under analysis violates national and EU data protection legislation.

6.2. In addition to the rights described in Article 6.1. above, ASSOCIAZIONE would like to point out that, in relation to your personal data, you have the right, where possible and appropriate, to exercise, on the one hand, the (sub)right provided for in Article. 19 of the GDPR ("The controller shall communicate to each of the recipients to whom the personal data have been transmitted any rectification or erasure or restriction of processing carried out pursuant to Article 16, Article 17(1) and Article 18, unless this proves impossible or involves a disproportionate effort. The data controller shall inform the data subject of such recipients if the data subject so requests"), to be considered connected and related to the exercise of one or more of the rights governed by Articles 16, 17 and 18 of the GDPR; on the other hand, ASSOCIAZIONE would like to inform you that, in relation to your personal data, there is, where

possible and conferring, the right to exercise the right provided for by Art. 22 paragraph 1) of the GDPR ("The data subject shall have the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning him or her or significantly affects him or her in a similar way"), subject to the exceptions provided for in paragraph 2) below.

6.3. In compliance with Article 12 paragraph 1) of the GDPR, the ASSOCIATION undertakes to provide the communications referred to in Articles 15 to 22 and 34 of the GDPR in a concise, transparent, intelligible, easily accessible form and in simple and clear language: this information will be provided in writing or by other possibly electronic means or, at the request of the interested party, will be provided orally provided that the identity of the latter is proven by other means.

6.4. In compliance with Article 12 paragraph 3) of the GDPR, ASSOCIATION hereby informs you that it undertakes to provide information regarding the action taken on a request pursuant to Articles 15 to 22 of the GDPR without undue delay and, in any case, no later than one month from receipt of the request; this period may be extended by 2 months if necessary, taking into account the complexity and number of requests (in this case, ASSOCIATION undertakes to inform you of such extension and the reasons for the delay, no later than one month from receipt of the request).

6.5. The rights described above (with the exception of the right pursuant to Art. 77 of the GDPR) may be exercised by means of the contact details set out in Art. 7 below.
